PROCESSING OF PERSONAL INFORMATION - EXPLANATORY TEXT

Your security is vital for us!

We as Çalık Denim Tekstil Sanayi ve Ticaret A.Ş., We would like to share with you the details of the "Law on the Protection of Personal Data", which is held primarily so as to protect the fundamental rights and freedoms of persons, including their privacy, and to protect personal data.

1. Data Official

In accordance with the Law on Protection of Personal Data (KVKK) numbered 6698, your personal data may be processed as the data official, by Çalık Denim Tekstil Sanayi ve Ticaret Anonim Şirketi (Company) within the scope explained as follows.

2. With which purposes the personal data may be processed

Your personal data collected shall include ensuring of the legal and commercial security of real persons who are in business relationship with the Company and the Company itself, and the personal data processing requirements set forth in Articles 5 and 6 of KVKK for the purpose of conducting the Company's human resources policies, and they can be processed within the objectives and conditions of processing of personal data.

3. To whom Your Processed Information can be transmitted and with which purposes may it be transmitted

Your collected personal data; may be transmitted to our business partners, suppliers, Group companies, shareholders, legally authorized public bodies and private individuals within the scope of the personal data processing requirements and purposes set forth under Articles 8 and 9 of the KVKK. Your personal data will not be used except for the purposes stated above and will not be shared nor be transferred to third parties except legal obligations and official institutions / organizations.

4. Method of Collecting Personal Information and its Legal Grounds

Your personal data is gathered through different channels such as Partnerships, Group Companies, Affiliates, business partners or solution partners with contractual relationships in accordance with the applicable legislations. Your personal data collected in line with this direction may also be processed and transmitted to the purposes set forth in (II) and (III) of the Explanatory/Clarifying Text within the scope of the personal data processing requirements and purposes set forth in Articles 5 and 6 of the KVKK.

5. Precautions relating to the protection of personal data

The company takes all kinds of technical and administrative measures required and necessary for the protection of personal data.

6. The Rights of the Holder of Personal Information indicated under KVKK article 11

As personal data owners, in the event that you submit your requests for your rights to the Company through the methods set forth as follows under the Public Disclosure Statement, your return will be carried out as soon as possible and within 30 days after the claim is evaluated/assessed. However, if a fee schedule is provided for by the Personal Data Protection Board, Çalık Denim Tekstil Sanayi ve Ticaret A.Ş. will charged over the fee officer as set forth on the relevant tariff.

In this scope, the owners of personal data shall;

- To learn whether the personal data are being processed or not,
- If the personal data were processed; requesting information relating to them,
- To learn the purpose of processing the personal information and whether they shall be used in

line with their purposes or not,

- Knowing the third parties to which personal data are transferred in Turkey or abroad
- Requesting the correction of personal data if it is incomplete or improperly processed, and requesting that third parties be notified of the processing carried out in this context,
- Requesting that the personal data be deleted or destroyed in the cases that the reasons for its processing are not fulfilled despite the fact that it has been processed in accordance with the provisions of Law No. 6698 and other related laws, and requesting that the process performed in this context be notified to third parties,
- Objection to the occurrence of a consequence against the data owner on the basis of particularly automatic analysis of the processed personal data,
- Having the right to claim damages in the event of a loss due to the processing of personal data against the laws/legislations..

7. Management of transmitting the demands

In accordance with the first paragraph of Article 13 of the KVKK, by attaching documents confirming and certifying your claim regarding the use of your abovementioned rights, you may have them sent to Büyükdere cd. No: 163 34394 Zincirlikuyu / Istanbul address via registered mail.
