#### **PURPOSES OF PROCESSING PERSONAL DATA**

## DISCLOSURE TEXT ON PERSONAL DATA PROTECTION WITH RE-GARD TO VISITORS

Your personal data will not be used for the purposes other than specified above and will not be shared or transferred to third parties other than legal obligations and government agencies.

#### METHOD AND LEGAL REASON FOR COLLECTION OF PERSONAL DATA

Çalık Denim may collect your personal data through visitor logs kept during your entry and exit to our company buildings or through cameras located in our facilities.

The legal reasons for the purposes of processing personal data can be considered as preparation of the necessary documentation and security provided by the legislation and official authorities within the scope of the obligations arising from the legislation to which our company is subject.

#### STORAGE OF YOUR PERSONAL DATA

Your personal data may be stored for the duration required for processing purposes. In the absence of any other reason or legal reason or absence of international law or regulation, and contractual obligations, your personal data will be deleted, destroyed or made anonymous when purposes of processing is terminated.

#### RIGHTS OF CONCERNED PERSON WHOSE PERSONAL DATA IS PROCESSED

You have the following rights in accordance with KVKK;

- Learn whether your personal data is being processed,
- Request information if your personal data has been processed,
- Learn about the purpose for which your personal data is processed and whether it is used for its purpose,
- To know the third parties to whom your personal data has been transferred at home or abroad,
- If your personal data is incomplete or improperly processed, request that they be corrected and that the transaction in this context be notified to third parties to whom the personal data was transferred,
- Request the deletion or destruction of personal data and to notify third parties of the transaction to which the personal data was transferred.
- Objecting to the occurrence of a result against the owner of the data exclusively, especially as a result of automatic analysis of the processed personal data,
- If you have suffered damage due to the illegal processing of personal data, request that the damage be indemnified.

#### IF YOU WANT TO CONTACT US FOR YOUR RIGHTS AND CLAIMS

You can send your request to our company by petition in accordance with eleventh article of the KVKK and the communiqué on the procedures and principles of application to the data officer, or by filling out the "application form for personal data" on the www.calik.com website or you can send it to our address mentioned above personally or by notarizing or by sending email through registered e-mail address (KEP): calikdenimtekstil@calikholding.hs03.kep.tr.

Personal applications to be made within this scope will be accepted following authentication by us and your requests will be finalized as soon as possible and within 30 days at the latest according to their nature. If the application is answered in writing, there will be no charge for up to 10 pages, and 1 Turkish lira may be charged for each page above 10 pages according to 7<sup>th</sup> article of the communiqué on application procedures and principles to the Data Officer. A transaction fee may be charged if the answer to the application is given in a recording medium such as CD, flash memory for the cost of the recording medium.
